Truro Guidebook Cover Competition Artist Permission Statement

In consideration of being allowed to participate in the Truro Chamber of Commerce Guidebook Cover Competition (the "Competition"), I, the undersigned artist (the "Artist"), hereby grant to the Truro Chamber of Commerce (the "Chamber") the following non-exclusive rights with respect to my artwork titled "[Artwork Title]" (the "Artwork"):

1. **Reproduction and Use:** The right to reproduce and use the Artwork, in whole or in part, on the cover of the Truro Chamber of Commerce Guidebook (the "Guidebook") and in any promotional materials related to The Chamber of Commerce, print and online.
2. **Right to Edit:** The right to edit, modify, or crop the Artwork for the purposes of reproduction on the Guidebook cover or in promotional materials. However, the Chamber agrees to make all reasonable efforts to maintain the integrity of the Artwork.
3. **Credit:** The right to credit the Artist for the Artwork by name. This credit will be prominently displayed on the Guidebook cover and in any promotional materials where the Artwork is used.
4. **Term:** The term of this permission shall be for five (5) years from the date of selection of the winning artwork.

The Artist retains all other rights to the Artwork, including all copyright ownership.

The Artist warrants that they are the sole creator of the Artwork and that they have the full right, power, and authority to grant the permissions set forth in this Agreement.

The Artist acknowledges that The Truro Chamber of Commerce is not obligated to select or use the Artwork in any way.

This Permission Statement constitutes the entire agreement between the parties with respect to the subject matter hereof and supersedes all prior or contemporaneous communications, representations, or agreements, whether oral or written.

By entering the Competition and submitting the Artwork, the Artist agrees to the terms of this Permission Statement.
